### **KWS Rules & Regulations Pertaining to Meal Facility**

One nutritious vegetarian meal (including Jain option) is available for students at set times at the KWS dining hall. KWS offers Meal facility via outsourced contract. KWS however, is responsible for the hygiene and safety of food preparation and maintenance of kitchen and dining facilities.

1. **The KWS Meal facility is mandatory for students from Nursery to Class 2** as a peer learning experience. Sitting and eating the same meal with your teacher and classmates is a learning experience in meal hygiene, dining decorum and nutrition.
2. The KWS Meal is an optional facility for students of Classes 3-12. KWS optional Meal facility for students from Classes 3-12 may be applied for only through the prescribed **Availing Optional Facilities Undertaking** form on our website. The filled-in application form, along with the the quarterly Meal fees should be submitted to KWS by the fifth day of March, June, September, and December.
3. The approval of your application for KWS Meal for students of Classes 3-12 is subject to your signing an **Availing Optional Facilities Undertaking** to abide by all meal decorum and hygiene guidelines. Any serious misbehaviour or indiscipline on your part may lead to cancellation of the optional Meal facility.
4. The optional Meal facility may not be demanded only for a part of the Academic Session. Once availed, Meal facility will mandatorily be applicable for the complete upcoming Academic Session, including calendar vacations and holidays. Only for parental convenience, the actual total annual expenditure on Meals per student is divided into four equal quarterly instalments. Parents should, therefore, take into consideration the total annual facility charges when calculating Meal expenses.
5. Meal charges will be payable as per KWS rules. Once paid, neither partial nor full Meal fees may be refunded in case of withdrawal / cancellation of Admission or of Meal during the Academic Session. Moreover, requests for availing of or for discontinuation/ cancellation of Meal facility, in the middle of the Academic Session will not be accepted by KWS.
6. Parents of students from Classes 3-12 who instead, opt to send tiffin from home should send nutritious and **vegetarian food** and avoid packaged instant foods to prevent obesity, diabetes, fatty liver and other health hazards that are unfortunately on the rise amongst children. Please send a clean napkin from home along with packed tiffin, which can be used as a table mat or to wipe any spillage. In case you forget your tiffin at home, parents are requested not to send any tiffin parcel to school due to security reasons. Instead, please intimate the KWS reception at least one hour in advance of recess for an alternative chargeable arrangement to be made.
